Type of Membership:

- **General Membership Annual fee: \$50.00**
Membership may be granted to a person who is or has been a member of the Unit, including the Reserves, National Guard, or DoD civilian who was assigned or attached to any active section for a period of 1 year or longer and departed under honorable circumstances. **Documents Required.**
- **Associate Membership Annual fee: \$50.00**
Membership may be granted to any person not qualified as above, but who has contributed significantly to the support of the Unit, or its lineage, in the accomplishment of its mission to include its creation. Applications for Associated membership are subject to the approval of the Membership Committee. Proof of contribution to the Unit must accompany the application.
- **Lifetime Membership One-time fee: \$300.00**
Lifetime status is available to new applicants. Lifetime membership may be paid in 4 even installments over a 4 year period; membership status will be carried as General or Associate member until the final payment has been made. Early payment is authorized.
- **Previously a member, upgrading to a Lifetime Membership One-time fee: \$250.00**
Previously General and Associate Members may upgrade their membership to Lifetime membership status at any time. **Note: previous membership must have been paid prior to January 1, 2017.**
